- FREE DEMAND SERVICE-Our collection commission is waved on the monies paid by debtor with the ten (10) day free demand period. PLEASE NOTE: We DO NOT accept accounts for FREE DEMAND ONLY; meaning that they cannot be withdrawn if they are not paid in full during this ten (10) day period.
- IMMEDIATE ACTION- If immediate actions is chosen, the free demand period is waved and we will institute our collection procedures immediately.
- We charge commission on all collections made on interest, service charges and commission charges added.
